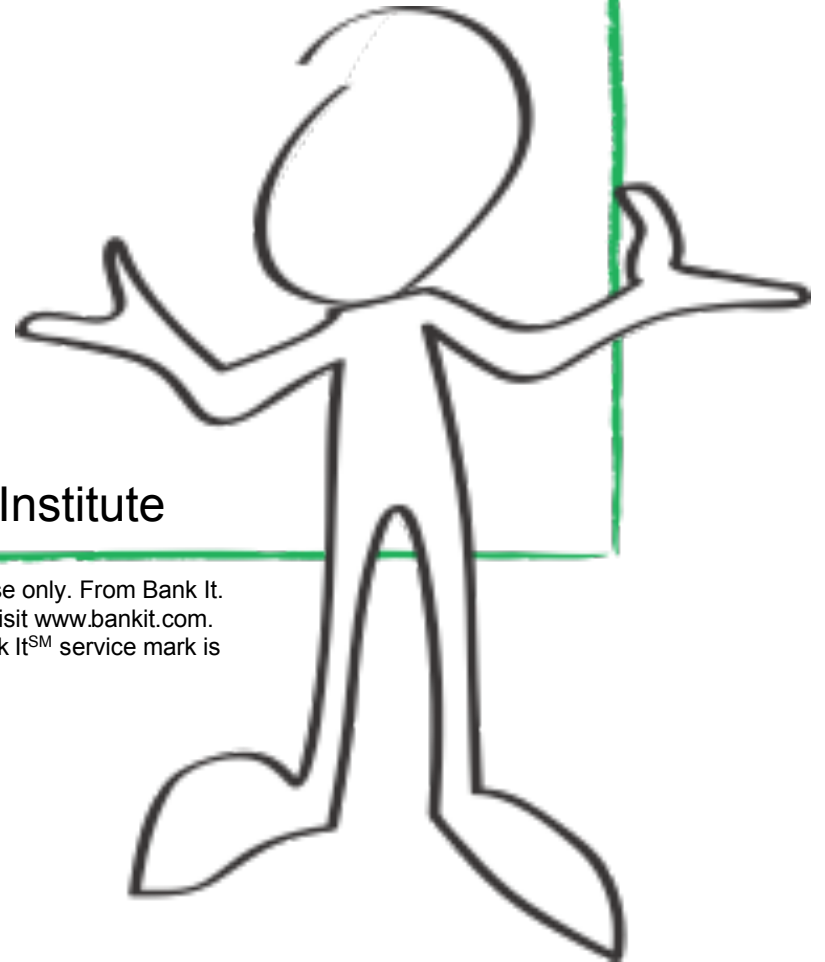

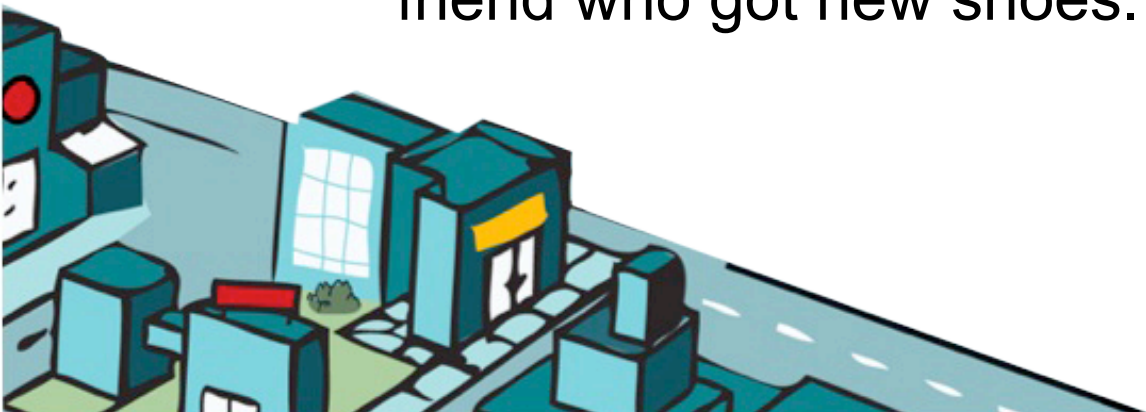

Review and Evaluate

How might a person use money to deal with an emotion?

- Shopping when you feel down.
- Not paying your parents back when you're angry.
- Going out to eat to celebrate something.
- Buying new shoes because you're jealous of a friend who got new shoes.

How can we show our love and care by the way we use our money?

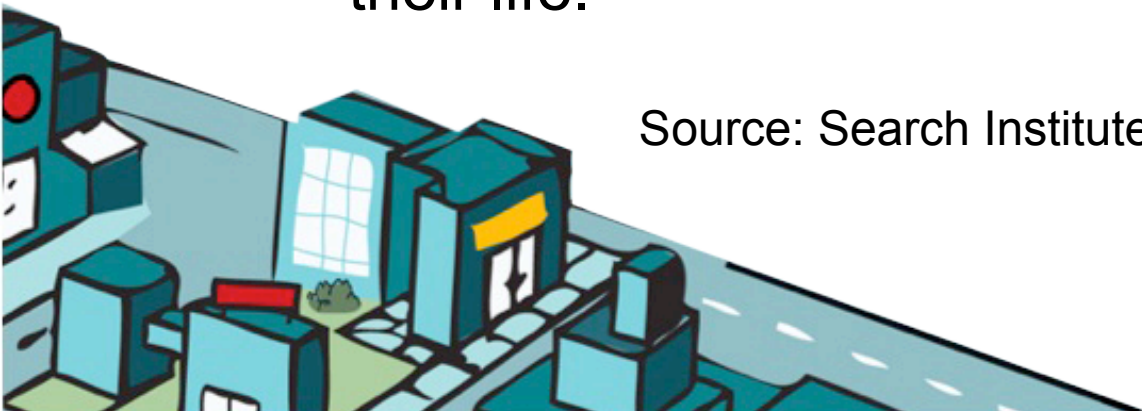

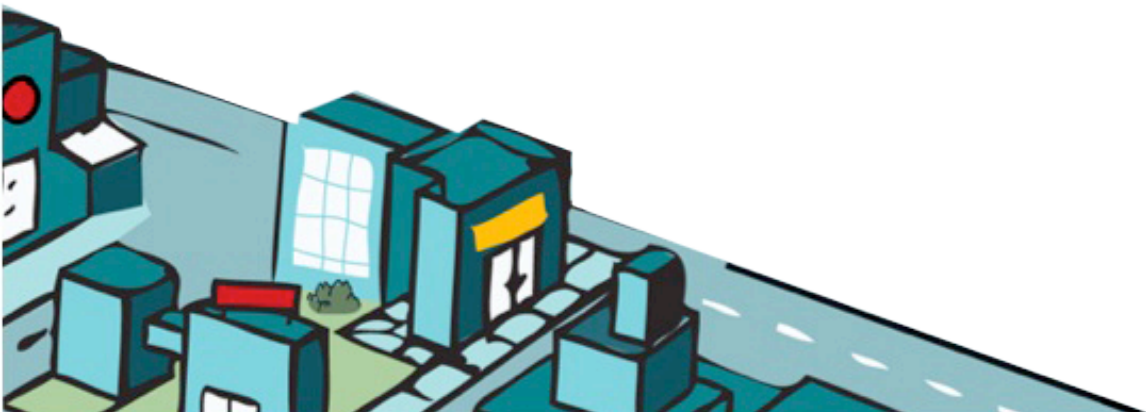
